BACKGROUND

The Client is of the opinion that the Breeder has the necessary experience, qualifications, and ability to match them with a Border Collie dog/puppy. The Client has already received consultation services from the Breeder, in regards to a dog that will match them.

IN CONSIDERATION OF the matters described above and of the mutual benefits and obligations set forth in this Agreement, the receipt and sufficiency of which consideration is hereby acknowledged, the Client and the Breeder (individually the "party" and collectively the "parties" to this Agreement), agrees as follows:

1. The Client agrees to the price of **\$500**, due within 48 hours of their signing of this Agreement as a Services fee (the "Fee"), for the already completed secretarial work, time, and consulting Services provided to them by the Breeder.
2. Gratis, The Breeder will reserves one Border Collie dog for the Client, of which the Breeder will refuse to sell to any other party, unless under the Terms and Conditions specified herein.

TERMS AND CONDITIONS OF THE FUTURE SALE OF A DOG BRED BY THE BREEDER:

- A. The agreed upon total purchase price of the dog is \$ _____ (the "Purchase Price"). The balance owing is the Purchase Price, MINUS the \$500 Fee = \$ _____ (the "Balance"). The Balance is due when the dog is eight weeks old, **OR**, if already older than eight weeks at the time of signing of this agreement, due within 72 business hours.
- B. Client requests and agrees that Breeder will choose a dog for them based on prior consultation. Client is aware that IF Breeder offers a dog that matches the Clients lifestyle as determined by the sole discretion of the Breeder, and Client refuses such dog, NO refund will be given to the Client for any Fee. *Dogs are NEVER chosen by the Client, and never placed based on colour!*

C. The Client is requesting a Dog born, or from a litter, born on, DOB (if known) _____, sired by _____ ex _____.

D. As a condition to Breeders acceptance of this deposit, the Client, by submitting this Agreement, has reviewed, accepts, and agrees to sign and be bound by the Terms and Conditions of an additional Contract governing the sale of the Dog.

E. CLIENT WILL FORFEIT THE FEE AND ANY RIGHTS TO THE DOG IF:

- Client fails to complete the purchase of the Dog for any reason,
- Client fail to pay the balance of the Purchase Price within the time limit specified
- Client refuses to sign the Breeders Contract.

In either event, Breeder shall be free to sell the Dog to another party at their sole discretion within 48 hours of the breach without any refund.

F. Client agrees to pick up the Dog between eight weeks old (date) _____ and nine weeks (date) _____ of age, with the exception being; if by fault of the Breeder due to vet requirements and other scheduling issues. If delay is the fault of the Purchasers it is agreed that a daily boarding fee will be incurred of fifty dollars per day, starting at nine weeks of age, unless otherwise stated and agreed upon in writing by Breeder. This fee covers food, boarding, and training. Breeder does not assume any liability in any shape or form, and will not issue any replacement or refund, for injury or death of Dog during the boarding period (after 8 weeks of age). All emergency and/or regular veterinary care (i.e. booster vaccinations/parasite control) will be continued according to the Breeders protocol, at the Breeders discretion, **at the expense of the Client.** All vet visits are subject to an additional \$50 fee to cover Breeders gas and time away from work.

G. If a dog is not available due to illness, death or any other reason, the Deposit will be refunded **or** transferred to a future dog, at the Breeders sole discretion, as agreed by the Parties.

H. THE SERVICE FEE MAY ONLY BE REFUNDED AT THE DISCRETION OF THE BREEDER, AND THE BREEDER CAN REFUSE THE SALE TO THE CLIENT BY REFUNDING THE FEE AT ANYTIME PRIOR TO THE CLIENT TAKING PHYSICAL POSSESSION OF THE DOG, WITH NO EXPLANATION.

The Purchaser has read and understands this Agreement in its entirety and agree that all parts and portions thereof constitute a binding Agreement. This agreement shall be governed by and construed in accordance with the laws of the location of the Dogs birth. (Maryland, USA/Ontario, Canada)
